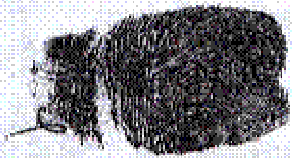

POWERS AND DUTIES OF THE BOARD OF TRUSTEES

1. The board of trustees shall have power to carry on business and shall be entrusted with the management of the officers of the trust and shall have power to do such acts as in their opinion may be conducive to the attainment of the objects of the trust to right to veto being reserved to the President.

6. The Trust may acquire and take over all or any part of the movable or immovable properties.

7. The trust may sell, lease rent out mortgage, alienate, release or transfer any property or part and parcel of any property registered in it's name or belong to the institutions which are owned by the Trust.

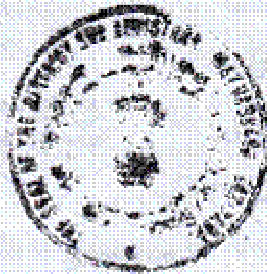

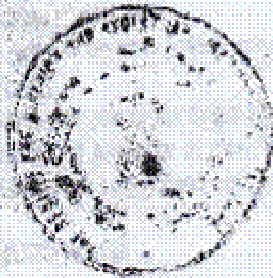
